- 09/07964/ATC** Fell two groups of sycamore suckers, one silver birch, one elder, one fruit tree and two hawthorns 1 High Street Wendover *The Parish Council has no objections provided that a flowering plum tree and a suitable alternative replacement tree be planted. This is an important visual amenity for the village.*
- 09/01982/ATC** Partial crown lifting and 30% crown reduction to one lime tree Land to front of Sturrick House 28 Aylesbury Road *The Parish Council has no objections.*
- 09/01983/ATC** Fell one cupressus, one ash, and one sycamore and raise crown and reduce one sycamore by 15% Sturrick House 28 Aylesbury Road *The Parish Council has no objections subject to agreement from the District Arboriculturalist.*
- 09/01993/APP** Single storey side and rear extension and new entrance porch 20 Carrington Crescent *The Parish Council has no objections*
- 09/02003/ATC** Removal of 10 trees 32 High Street  
*The Parish Council objects to this application due to the public visual amenity and request that landscaping plans be provided.*
