10. HS2

HS2 Complaint

P21/012 On 4th May an email was received from a resident of Wendover who had sent a complaint to HS2 on 19th April 2021 regarding extensive ground works in a field adjacent to Hale Road. He asked for further information as it was unclear as to what was happening because he had not seen any planning applications. On 19th May 2021 the Senior Engagement Manager from Eiffage Kier replied stating that the works being undertaken were private works for Boswell Farm. Eiffage Kier were currently working on the A413. All consents were in place and were required to construct an access road direct to the main worksite along the route. This would allow Eiffage Kier to take large loads off the local road network and to bring material directly to the site.

HS2 Notice of Works

P21/013 On 28th April 2021 notification was received from the HS2 Department of Transport stating that a number of surveys would be carried out on Hampden Pond and The Witchell between 1st June and 30th November 2021. On 10th May 2021 the Chairman of Wendover Parish Council emailed Duty of Care at HS2 stating that Wendover Parish Council were not minded to grant access to the two areas until further

information had been received. On 19th May 2021 Eiffage Kier working on behalf of HS2 advised that water surveys would be carried out which will include inspections of culverts and drains, water sampling, botanical surveys, river catchment and groundwater dependent terrestrial ecosystem wetland environments. Work would be completed by 30th November 2021 and 48 hour's notice would be provided giving notice of entry.

HS2 Hydrology Report

P21/014 On the 8th May the Chairman of Wendover Parish Council emailed the Head of Transport at Buckinghamshire Council asking if they could forward the comments, questions and answers they had received following an exchange with HS2 Ltd and EKFB in relation to questions on noise and hydrogeology issues.

HS2 Wendover Dean AVDC P2 Schedule 17 Application

P21/015 On 19th May 2021 notification was received from Bucks Council Planning that the determination date for the Schedule 17 application for the viaduct had been extended until 28th May 2021.

HS2 Update from the Chairman of Wendover Parish Council

P21/016 Councillor Bulpett advised the Planning Committee that she had been sent the proposed future local works for HS2 by Eiffage Kier. The document also highlighted the anti-social behaviour by the HS2 Protestors at Jones Hill Wood.
