Management Protocol – Footpaths

Objectives

The objective of this document is to define the best practice, guidelines, and targets for the management of the Footpaths devolved to Wendover Parish Council.

The protocol is managed and agreed by the Amenities Committee and implemented by the Clerk and Groundsmen.

General Policy

The policy of the Council is to manage the general environment of the footpaths.

Parish Council Maintenance Policy

- WPC will maintain the ground by a siding out between the months of October and March with extra for years of mild winters of excessive growth.
- WPC will maintain the hedgerows to encourage wildlife but will not cut between April-August inclusive due to the nesting period.
- Litter will be collected and disposed of on a regular basis.
- Where necessary epicormic growth will be cut back and removed annually.
- WPC will maintain rules devolved by Buckinghamshire Council under contractual terms and conditions. Buckinghamshire Council remains responsible for legal enforcement.
- All proposed changes to footpaths must be in agreement with the Amenities Committee.

Devolved Footpaths

Footpaths that have been devolved to Wendover Parish Council from Buckinghamshire Council:

38	Close to Bowood Lane Wendover Dene
39	Near Roberts Wood Cottage, Rocky Lane near London Road
57	Parallel to London Road by Grove Farm
