# **ITEM 6 – CLERK'S REPORT INCLUDING HISTORY AND CORRESPONDENCE**

#### Old Scout Hut on Heron Path

A communication has been sent to the owners outlining some of the damage and issues with the boundary fencing that is allowing unauthorised access into the property and facilitating Anti Social Behaviour. The owners have been requested to undertake remedial works to help prevent access and make parts of the fence safe.

We have yet to have a response but are aware that the Chair of the Wendover Parish Council planning committee is in contact.

#### **Skatepark Application**

The skatepark application has come back to the Buckinghamshire Council planning team as we have now submitted the requested additional reports on noise and Biodiversity Net Gain. The noise impact survey shows that the location and design of the skatepark will have minimal impact on residents and that there is some planting we need to undertake to offset the loss of grassed space.
